This policy applies to Paper Australia Pty Ltd (ABN 63 061 583 533) together with its subsidiaries, including Opal Packaging Australia Pty Ltd (ABN 77 636 682 883), Opal Commercial Services Pty Ltd (ABN 56 637 020 467), Paper Products Marketing Pty Ltd (ABN 78 069 837 592) and Opal Packaging New Zealand Limited (NZBN 9429047752900) (collectively referred to as **Opal**) including its directors, officers and employees while conducting Opal's business and undertakings. Opal is a leading producer and supplier of packaging, paper and other products. Opal may vary and update this policy from time to time.
